To obtain a building in the Town of Lima, an erosion control/site permit may be required by the Rock County Planning Department (608)-757-5587/Land Management Department (608)-754-6617. Please contact them for all County permit requirements. County permits must first be obtained prior to the building/zoning permit.

- All residential decks and/or porches
- All residential accessory structures
- All electrical services: including new and upgrades
- All Commercial/Industrial new construction, additions/alterations, and change of use

Permit Fees:

ZONING PERMIT FEES:

Zoning fees cover the cost for the review of zoning permit applications and zoning questions. Items reviewed include: street setback, side yard, rear yard, building height, use, building/sign size and commercial parking. Items NOT included are: review of annexation, rezoning, conditional use permits, commercial site plans, land divisions, variance applications, etc. All Zoning permits require an accurate site plan drawn to scale at time of permit submittal.
